

## **Supporting Our Community**

In recent months, people in our county have experienced fear, uncertainty, and hurt as federal immigration activities have impacted our community. Our community is facing this uncertain moment by coming together to support each other in this time of need.

I personally talked with and heard from parents, brothers, sisters, spouses and children of those who were detained on July 10th in the unincorporated area of Camarillo. It has been reported that as many as 493 people in Ventura County have been detained since January. In this wake, our local community-based organizations have made calls to support families with groceries, diapers, rent and utility payments. And also, access to trusted and qualified legal resources, support, knowledge, and education.

Our Board of Supervisors has a regularly scheduled meeting on Tuesday, August 12th where I have requested that we receive a report on the community impact of the recent federal immigration actions. We will hear from: MICOP, 805 UndocuFund, Economic Development Collaborative, and the County's Public Defender's Office, Human Services Agency, and Health Care Agency.

I have seen our County come together to marshal resources for our neighbors during times of need in recent years. The work that is already ongoing at our schools, by community-based organizations, and by neighbors-helping-neighbors is something to be proud of.

I am calling on our Board to support our community during this time of need, particularly in areas where we can be most impactful – supporting access to legal rights education and legal resources and supporting access to local programs for our youth. Specifically, during our August 12th Board meeting, I am requesting that the County:

• Establish and appropriate \$250,000 to a **Ventura County Immigration Legal Defense Fund** that would provide grant awards to community-based organizations that

can bolster access to a broad scope of accessible legal, educational, and outreach resources to ensure access to due process, legal resources, and legal rights education in our community.

- Support the **Public Defender's Immigrant Defense Unit** by approving seven positions for three years to continue providing and expand post-conviction services and some immigration related legal services to our community.
- Prepare to support the Migrant Education Program, run by the Ventura County Office
  of Education, should the federal funds that currently support the program be
  significantly reduced or eliminated.
- Create protocols, policies, and trainings to support County staff working in public settings regarding access to and use of County facilities by federal officials engaging in immigration enforcement activities.
- Amend our current **legislative platform** so the County can engage in conversations about relevant, immigration-related policy proposals from state and federal representatives.
- Reallocate my upcoming salary increase from my budget to the Ventura County Immigration Legal Defense Fund.

Our work is not a one-day response, or one-time. But it is about meeting the most urgent needs of our community as we look to the future: to build a Ventura County where every person that resides here can grow up with a good education, have a good and steady job, raise a family and be healthy and safe.

# Cutting Edge Air Quality Innovation at the Port of Hueneme

On July 16th, building on their green legacy, the Port of Hueneme unveiled their second STAX Emissions Control Barge known as STAX 6 establishing the Port of Hueneme as one of only two California ports operating multiple STAX barges. What does this mean for our port employees surrounding and communities? This innovative system will filter out 99% of particulate matter and 95% of nitrogen oxides directly from ship exhaust, reinforcing the port's role as a leader in clean air infrastructure, building on years of green milestones such as Green Marine certification, electric equipment and shoreside power, and staying true to their vision of Zero Emissions by 2020.

# Karl's Village Project to be Reviewed by Coastal Commission

The California Coastal Commission will hold a hybrid public hearing starting at 9 a.m. on Thursday, August 14th, 2025. At the meeting, the Commission will consider action to amend the certified Channel Islands Harbor Public Works Plan to incorporate the construction of Karl's Village and consider action on the Notice of Impending Development (NOID) by Ventura County Harbor Department for the demolition of Fisherman's Wharf and construction of Karl's Village.

Karls Village is an ongoing project to revitalize part of the Channel Island Harbor via an 11-acre visitor-serving development featuring retail, dining, recreational attractions, and public waterfront access improvements located at the corner of Channel Islands Boulevard and Victoria Avenue within Channel Islands Harbor, City of Oxnard, Ventura County.

### **Apostille Services Brought to Ventura County**



Thank you to the Ventura County Clerk-Recorder & Registrar of Voters for bringing Apostille services directly to our residents on July 29th, giving people the opportunity to connect directly with the California Secretary of State without having to drive to Sacramento or Los Angeles.

By the end of the day, 315 people received apostille certification on 712 documents, impressive stats for the first time holding this event. The Clerk-Recorder hopes to partner again with the State team soon to continue to bring this important service back to the community. Thank you to all the staff who made this event possible!

The weeks surrounding the Fourth of July are especially hard on animal shelters, with many animals arriving after being startled by fireworks and becoming separated from their families. Ventura County Animal Services (VCAS) is experiencing unprecedented overcrowding at the shelter. It's comforting to know many of the misplaced animals left the shelter after just a short time due to the great work VCAS does reuniting lost pets with their owners.
